The WP4 represents the "application" of the learning process started with the capacity building activities (WP2 and WP3). The pilot projects then translate on the ground the knowledge acquired in specific sectors. The Action foresees working in the two areas identified as priorities by the municipalities:

4.1. Pilot Action: Fishery Involving 5 coastal municipalities: Sirte, Zliten, Benghazi, Tripoli, Tobruk;

In Libya there is still a strong fishing tradition, both in terms of know-how and training structures. Nevertheless, many supporting structures have been damaged by recent events. In such a context, the partnership promotes cooperation with local stakeholders according to a bottom-up approach to reinforce the traditional fisheries sector. The pilot action on fishery is implemented in the framework of the REBUILD project and involves Libyan municipalities of Sirte, Zliten, Benghazi, Tripoli, Tobruk. The action aims at making available to local communities involved in fisheries and related productive sectors a facility for the storage and management of fish, to allow its conservation, refrigeration, commercialization, preparation for delivery to customers and delivery (a comprehensive traceability system for the supply chain in the fishery sector). This is to ease the commercialization of fish at local and international markets.

The three main pillars of the pilot activity on fishery are:

- Supporting the definition of traceability and certification paths in the fishery sector according to the current EU legislation (storage, refrigeration and management processes)
- Strengthening local training institutions and promoting training courses aiming at
 enabling young Libyan fishermen to reach the adequate skills required to improve
 their abilities to contribute to local development in the field of fisheries
- Pilot test in one of the five municipalities (previously identified) for infrastructure compliance with EU regulations for conservation, refrigeration, commercialisation, and preparation for delivery to customers.

This pilot project is the follow-up of PATH-DEV, a project managed in 2017-2019 by The Friuli Venezia Giulia Autonomous Region and five Libyan coastal municipalities (coapplicants in PathDEV) in the framework of the Nicosia Initiative, funded by the Italian Ministry of Interior. The management of the pilot project is led by the Friuli Venezia Giulia Autonomous Region, with the technical support of the Italian National Institute of Oceanography and Applied Geophysics (OGS) acting as technical assistance partner to the Friuli Venezia Giulia Autonomous Region.

The overall objectives of services required are:

- to provide a co-working space at SBR preises for the duration of the project and facilitate the collaboration at a local level of the field officers and the experts

3. ASSUMPTIONS & RISKS

The services required may be affected by the security situation in Libya and the Covid-19 pandemic. They shall be sufficiently controlled to allow participation of Libyan and international partners in the relevant activities.

4. SCOPE OF THE WORK

The tasks to be undertaken in order to achieve the contract objectives foreseen in Section 2 shall include the following non-exhaustive list.

1. SUPPLY OF LOCAL EXPERTISE

Provision of the contracting of the local experts under the domestic law for the implementation of the Pilot Action Fishery with the support of OGS in charge of the publication of profiles, identification and selection of candidates. The selected experts will operate under the coordination of the OGS Project Management in Italy and Libya, and in co-operation with the correspondent international experts.

2. CO-WORKING SPACE AND FIELD OPERATION

3. FURTHER INFORMATION

3.1. Duration of the contract

3.2. Location

The activities for which the provision of the above mentioned services (supply of expertise) is required will take place in Libya and Tunisia, with possible interaction with Italy. The location of the meeting venues must be agreed OGS according to the specifications outlined above.

3.3. Pandemic

The service provider must comply with public health regulations and in particular with containment rules and measures due to the COVID-19 epidemiological situation.

3.4. Other services

In addition, upon express and ad-hoc request from the OGS, the purchase of additional services may also be agreed upon.

5. BUDGET

1. SUPPLY OF LOCAL EXPERTISE
